In this regard we inform you of the following:

The personal data we collect from you will be used for the following purposes that are necessary for the service you are requesting:

- For your safety and the safety of the people who will be attending Expo Transporte ANPACT 2021.

Additionally, we will use your personal information for the following secondary purposes that are not necessary for the requested service, but that allow and facilitate us to provide you with better customer service:

- Commercial prospecting.

The refusal to use your personal data for these purposes may not be a reason for us to deny you the services and products you request or contract with us. To carry out the purposes described in this privacy notice, we will use the following personal data:

Likewise, we inform you that your personal information is shared within the country with AHM Registro y Asociados S.A. de C.V., since it will be the company in charge of elaborating the access badges to Expo Transporte ANPACT 2021.

You are also informed that you have the right to know what personal data we have about you, what we use them for and the conditions of the use we give them (Access). In addition, it is your right to request the correction of your personal information in case it is outdated, inaccurate or incomplete (Correction); that we remove it from our records or databases when you consider that it is not being properly used (Cancellation); as well as to oppose the use of your personal data for specific purposes (Opposition). These rights are known as ARCO rights.

To exercise any of the ARCO rights, you must submit the respective request by sending an email to info@bynexpo.com.

In relation to the procedure and requirements for the exercise of your ARCO rights, we inform you of the following:

You can prove your identity as the owner and, if applicable, your representative, by physically presenting the application, accompanied by a copy of the official identification of the owner and, if applicable, a simple copy of the power of attorney for acts of administration of the owner's representative or a simple power of attorney signed by the owner, by the proxy and by two witnesses, and a simple copy of the official identification of the representative or proxy. The request may also be sent via e-mail to the following address: info@bynexpo.com.

The information and/or documentation that the application must contain is as follows:

- 1. Name of the owner and address or other means of communicating the response to your request;
- 2. Documents proving the identity or, where appropriate, the legal representation of the holder;
- 3. A clear and precise description of the personal data with respect to which it is sought to exercise any of the ARCO rights;
- 4. Any other element or document that facilitates the location of the personal data.



We will respond to your request within 20 working days of receiving it through the means you have indicated in your request. We do not omit to inform you that the personal data you request may be reproduced in printed and/or digital media.
